

Student and On-Site Instructor Health & Safety Requirements

On-site clinical program faculty and students shall be required to comply with the health standards applied to hospital employees. Pre-clinical requirements for immunizations, certifications, TB screening, substance abuse testing, and fingerprint clearance cards for clinical program faculty (on-site) and students shall be in keeping with the policies applicable to employees.

Evidence is required confirming each student/on-site faculty has met HonorHealth's immunization, safety and other requirements set forth below.

1. **Immunization** - Proof for the following diseases:
 - a. **Influenza** - Current seasonal influenza vaccine or exemption acceptable to HonorHealth. If vaccine is waived/declined, student/on-site faculty must wear a mask in all patient areas while at HonorHealth.
 - b. **Measles/Mumps/Rubella** - Two (2) Measles/Mumps/Rubella (MMR) vaccinations (given at least twenty-eight (28) days apart and after one year of age) or MMR lab titer showing positive immunity.
 - c. **Varicella** - Two (2) Varicella vaccinations or lab titer showing positive immunity
 - d. **Hepatitis B** - Hepatitis B vaccine or lab titer showing positive immunity or signed waiver/declination.
 - e. **Tuberculosis (TB) screening** - Two-step negative TB skin test within twelve (12) months of the date of placement at HonorHealth or proof of a negative chest x-ray within six (6) months of the date of placement if history of positive TB skin test.
2. **Drug Screen** - Within the last year of the start of such placement, each student and any on-site faculty must have passed a urine drug screen for substance abuse using a standard panel. If the appropriate screening has been done by the school, this can be noted in the letter of good standing. If the school cannot verify that a satisfactory screening was performed, applicants must complete a screening at an approved location.

The standard panel includes the following substances:

- a. Amphetamines

- b. Barbiturates
 - c. Benzodiazepines
 - d. Cannabinoids
 - e. Cocaine or Metabolites
 - f. Opiates
 - g. Oxycodone
 - h. Phencyclidine
 - i. Propoxyphene
 - j. Methadone
3. **Level One Fingerprint Clearance Card** - Each student and any on-site faculty are required to obtain and maintain a valid Level One Arizona Department of Public Safety Fingerprint Clearance Card throughout his/her placement at HonorHealth. This fingerprint clearance card must encompass state and federal checks for criminal and sex offender crimes.
4. **Basic Life Support Certification** (Healthcare Provider Level) - Each student/onsite faculty must maintain a current Basic Life Support certification from the American Heart Association throughout their rotation at HonorHealth. Certification must include evidence of hands-on skills component.

Acquisition of all pre-admittance requirements (drug screening, fingerprint clearance cards, immunizations and certifications) will not be the responsibility of HonorHealth. All requirements must be met before on-site instructors or students begin their learning experiences at HonorHealth. Results of all testing will be kept on file at the educational institution.

Students or faculty who do not comply with HonorHealth policy in all above requirements will not utilize HonorHealth for (clinical) rotations, internships, or externships.

If you have completed all the above requirements and the school representative verifies completion, the student orientation is then coordinated. A student orientation will not be coordinated until all necessary requirements are on-file at the school and at HonorHealth.
